Description

2017 Smuggler Strata 800 Mid Cabin Amphibious RIB, built by Smuggler Marine in New Zealand, with 250 hp Yamaha F250 4-stroke outboard motor (2020), full service history (last serviced in 2024), Orion amphibious technology in lieu of Sealegs technology (new engine 2020), Hypalon tubes and warranties still in place. A well presented, fully equipped and lightly used example of these amphibious rigid inflatable boats, renowned for their build quality and dry soft riding hull, which was commissioned for its Guernsey based sole owner in 2020. This amphibious RIB is a boater's dream, with hassle-free days on and off the water for all the family. Early inspection is essential.

- 250 hp Yamaha F250 4-stroke outboard motor with 3 blade s/s propeller (2020) gives 48 knots maximum speed (25 knots cruising)
- Full Yamaha instrumentation (approximately 106 hours) and single lever control with kill switch
- Power assisted hydraulic steering

- Orion Marine 3-wheel braked hydraulic drive mechanism (new engine in 2020) with wide all-terrain tyres which retract behind specially designed D-tubes aft and into a forward recessed bow pod
- 12 volt DC electrical system (2 batteries) with isolator switch, 6-Way switch / distribution panels (2) and socket
- 220 volt AC shore supply with battery charger
- Remote controlled anchor windlass with through-hull s/s bow roller
- Electric fresh water bathing shower
- Automatic electric bilge pumps (2)
- Sea water deck pump with hose
- Live bait tank
- Console / cockpit lights
- Aft cockpit floodlight
- Dual action electric pump for tubes

COCKPIT LAYOUT

- Fore and aft cockpits with full width mid cabin / centre console, Tek Dek decking and UV resistant upholstery
- Large centre console with wrap-around windscreen and double helm seat with reversible backrest
- Large well protected aft cockpit
- Steps on tubes up to side platforms on either side of cabin / console leading forward to separate cockpit / sun deck
- Forward seat (with built in chilly bin) and large forward-facing seat on console (infill cushion converts to sun deck)
- Fully moulded GRP engine well with seats and Tek Dek boarding platforms on either side
- Good stowage including anchor locker, large locker under helm / forward console seats and aft cockpit lazarette
