Description

2007 Regal 3550 which, after having been imported into the UK in 2016, was fitted with twin 220 hp Volvo Penta D3-220 diesel engines in 2018 and subsequently underwent a Post Construction Assessment in order to comply with the Recreational Craft Directive (RCD), resulting in a new Hull Identification Number (GB-HPI99080D818) being issued. Comprehensive inventory includes DSC VHF radio, multi-function display (chartplotter / depthsounder), electric anchor windlass, holding tank, cabin heating, shore power with charger, camper cover, tender and outboard motor. Purchased by the current Guernsey based owner in February 2022 and engines / stern drives last serviced in March 2023. A reliable and competitively priced sports cruiser with low hours and spacious accommodation for 2 / 4 persons.

ACCOMMODATION

- Spacious accommodation for 2 / 4 persons in open plan cabin and cockpit
- Large “U” shaped forward seating area with table (infill converts to double berth)
- Separate heads compartment to port with Dometic VacuFlush marine toilet and wash hand basin / shower
- Cabinet housing DC / AC distribution panel, Dometic drawer fridge and Kenwood microwave oven opposite
- Opening deck hatch and portlights provide adequate ventilation
- Steps up to open self-draining cockpit with double helm seat and console to starboard
- Mirrored passenger seat opposite
- Access to foredeck via steps and door in centre of windscreen
- Central cockpit wet bar with sink on port side and Raritan fridge opposite
- Large “U” shaped aft seating area with sockets for table (converts to 2 single sun beds or occasional berths)
- Central transom gate to very large teak boarding platform with s/s telescopic bathing ladder
- Good access to engine compartment
- Ample stowage throughout cabin and cockpit including 4 useful transom lockers
